## **INGOT SC LTD's Copy Trading Risk Disclosure**

INGOT SC LTD (the "Company") offers its users Copy Trading features, allowing them to copy other traders' trades or use specific trading strategies. Users (either Providers or Followers) must consider their financial situation and commitments before benefiting from this service. They should be aware that Copy Trading features are highly speculative and can lead to massive losses. Copy Trading risks include automated trading execution that can result in trades being opened and closed without manual intervention.

By using the Copy Trading service, Users acknowledge that they are solely responsible for any losses or damages that may result from copying trades or using the service. Users are encouraged to carefully review and consider the risks associated with Copy Trading before deciding to use the service.

Copy Trading features are provided solely for informational purposes, and the Company and its affiliates, employees, and agents are not financial advisors. Users who make investment decisions based on the information available on the website or as a result of using Copy Trading features do so at their own risk, and the Company, its affiliates, employees, and agents will not be liable for any losses that may be incurred.

Users should conduct their own research before making any investment decisions, and they are solely responsible for determining whether an investment, strategy, or any other product or service is appropriate or suitable for them based on their investment objectives and personal and financial situation.

Users (either Provider or Follower) acknowledge that the Follower has chosen the Provider upon the Follower's own research assessment and on the Follower's own risk, and upon Follower and Provider's mutual understanding without any recommendation or reference by the company or any pre-set criteria by the Company.

If a user copies a trader (the "follower"), the copied positions portions will be according to the Follower choice of the options available on the Copy Trading platform at the time of the copied trade. Trades below the minimum trade amount will not be opened. Users should be prepared to bear the loss of the entire investment made in the copied trade.

If a user places additional trades in their account or modifies or cancels an order generated by a Copy Trading feature, they may achieve a materially different result than the user they copied. Additionally, cash outs and withdrawals by the copied trader (the "Provider") may also affect the Copy Trading proportions.

Past performance, risk scores, statistics, and other information with respect to users appearing on the website or application are not indicative of future results and should be considered hypothetical. It is

important to understand that risk scores, statistical information, and historical performance are not a guarantee of future performance.

the Company does not guarantee the execution of any trade from the provider that is being copied, and the trade may be executed at a different price depending on various factors, such as market conditions.

The Company will not execute any trade for products that are not available to the Follower (whether as a result of Applicable Law or otherwise) and/or if the amount is lower than the minimum trade.

the Company does not guarantee any order, including the placing of stop orders such as Copy Stop Loss. Accordingly, regardless of the entry or closing designation, the Company does not guarantee that the trade will be filled at the order price/stop loss percentage, and users may lose more than the original amount used to copy such a trade.

The Follower acknowledge that in the event of the Provider been liquidated for any reason, then all the Follower's opened copied trades/positions will be closed automatically at the same time of Provider's liquidation.

Past performance and/or risk scores should be considered hypothetical performance results. Hypothetical performance results have many inherent limitations. No representation or guarantee is made that any account will or is likely to achieve profits or losses similar to the past performance or risk score . The actual percentage gains/losses experienced by investors will vary depending on many factors, including starting account balances (deposits and withdrawals), market behavior, the investor's account settings, and the actual performance of the copied user.

Follower and Provider authorize the Company without the need to any prior notice to any of the Users, to take all the necessary actions in order to transfer from the Follower's trading account to the Provider's trading account at the Company, any amounts may be entitled to the Provider from the Follower as a result of Copy Trading as mutually agreed by and between the Follower and Provider on the Copy Trading Platform.

All trades taken by the Follower and Provider will be considered as separate trades and will be performed by the Company according to the Client Agreement, other Terms and conditions and policies which were made available to the Users and published on the Company's website.

TO THE EXTENT PERMITTED UNDER APPLICABLE LAW THE COMPANY PROVIDES NO WARRANTY AND MAKE NO REPRESENTATIONS ON THE QUALITY OF THE PLATFORM AND SERVICE. BY USING COPY TRADE SERVICE, USERS (PROVIDER AND FOLLOWER) DO SO SOLELY AT THEIR OWN RISK. The Company shall have the right without a notice, to pause, stop, or block: (a) any Provider from being copied; and (b) any portfolio or trading strategy from being copied. In this case, open trades entered into as a result of the Copy Trading will be closed.

The Company shall have the right to terminate the Copy Trading for any User (either Provider or Follower) without a cause and without the Company being held liable for any compensation from whatsoever kind or nature, upon providing the User/Users with a two-days written notice. After the termination of the Copy Trading, all the Follower’s opened positions shall be at Followers own responsibility and the opened positions of the Provider shall be at the Provider’s sole responsibility.

The Company reserves the right to amend the terms of the Copy Trading without any consent from the User/Users.
