- 1. Organizer:** Rise is a trademark of INGOT SC Ltd, with its business address at Unit 3, 2nd Floor, Dekk Complex, Plaisance, Mahé, Seychelles. INGOT SC Ltd is registered in Seychelles as INGOT SC Ltd. INGOT SC Ltd holds the Securities Dealer License number SD117 issued by the Financial Services Authority of Seychelles (FSA).
- 2. Participants:** This Campaign is limited to Customers who meet the participation criteria set out in these Terms and Conditions (hereinafter referred to as the “Participant”). This Campaign constitutes an annex to the Customer Service Agreement, and participation therein shall be deemed an explicit acknowledgment by the Participant that they have reviewed, understood, accepted, and agreed to be fully bound by these Terms and Conditions.
- 3. Duration:** This Campaign shall be valid throughout LaLiga session 2026-2027
- 4. Campaign Objective:** The objective of this Campaign is to enable Participants to experience a comprehensive trading environment through an approved platform, featuring competitive trading conditions, deep liquidity, and seamless, direct access to a wide range of global financial markets, thereby enhancing the overall trading experience and providing a fair and transparent environment that supports Participants in achieving their investment objectives.
- 5. Participation Requirements:** To participate in this Campaign, the following conditions must be met:
 - a)** The Campaign is available to newly onboarded Customers who have completed 100% of the account verification procedures and have opened a trading account after the date of June, 17 2026.
- 6. Eligibility for Draws and Prizes:**

First: General Conditions

- a)** Full compliance with the participation requirements and the Campaign Terms and Conditions is mandatory.
- b)** This Campaign may be participated in only once per trading account, and participation through multiple accounts by the same Customer shall be treated as separate participations.

9. Revoking and cancelling the Campaign

- 9.1.** RISE shall revoke and cancel the Campaign for Customer(s) or Introducing Broker(s), along with their introduced Customer(s), in any of the following cases:
- a) Failure to meet or maintain any of the Terms and Conditions.
 - b) Breach of the Agreement.

- c) Suspension, restriction, or closure of the trading account or the Customer's account.
 - d) Violation of RISE's laws or internal policies.
 - e) If the Customer is an employee, director, consultant, agent, service provider, or board member of Rise or INGOT, or is employed by the parent company or any subsidiary, sister, or affiliated company, or is a shareholder or partner therein, or is an immediate family member thereof (such as spouses, children, parents, or siblings), or their representatives or agents.
- 9.2.** Notwithstanding the above, RISE reserves to cancel and revoke this Campaign at any time, at its sole discretion, without reason or justification or notification from whatsoever kind or nature.

10. Exclusive Participation in the Campaign

- 10.1.** No Customer who is participating in, or benefiting from, any other campaign, promotion, bonus, incentive, or cashback program, including any special promotional arrangements or terms granted through the Introducing Broker under which the Customer is registered, shall be eligible to participate in this Campaign and shall be deemed ineligible.
- 10.2.** RISE reserves the right, at its sole and absolute discretion and without prior notice, to exclude the Customer, cancel or revoke the Customer's eligibility, withdraw any benefits, or terminate participation in this Campaign if it is determined that the Customer is simultaneously benefiting from another campaign or from any special promotional arrangements through the Introducing Broker under which the Customer is registered.

11. General Terms

11.1. RISE's Rights and Reservations:

- a) All decisions issued by RISE in relation to any aspect of the Bonus Scheme shall be final, binding, and conclusive. No correspondence, inquiries, appeals, or objections (whether oral or written) shall be considered.
- b) RISE reserves the right to exclude any Participant who is suspected or proven to have manipulated the participation process, interfered with or disrupted the Campaign, or breached the Customer Agreement or these Terms and Conditions.
- c) RISE reserves the right to amend or modify these Terms and Conditions (or any part thereof) without prior notice or consent. RISE also reserves the right, without any liability, to revoke, cancel, postpone, or suspend the Bonus Scheme at any

- d) The winner accepts the publication of their **full names** on our website and social media channels.

11.2. Suspicion of Abuse, Arbitrage, or Fraudulent Activity:

- a) If RISE determines, at its reasonable discretion, that a Customer has engaged or attempted to engage in any form of arbitrage (including risk-free profit strategies), abuse (such as trading patterns indicating an intention to exploit the Bonus Scheme without genuine market participation or risk exposure), fraud, manipulation, or any unacceptable or prohibited trading behaviour, RISE shall have the right to cancel all trades associated with such activities and/or void any trades directly linked to the abuse of the Bonus Scheme.
- b) In addition, and without prejudice to any other rights under any agreement with RISE, RISE reserves the right, at its sole and reasonable discretion, to:
 - i. Close or suspend, temporarily or permanently, all accounts.

No Customer or Introducing Broker shall be entitled to any reimbursement, compensation, or replacement benefit of any kind arising from or in connection with such revocation or cancellation, and RISE shall not be required to restore, reinstate, or substitute the Bonus Scheme or any part thereof.
